- It is recommended that CE be completed in ample time for providers to issue certificates of completion and for credits to be reported and banked before the compliance due date.
- 6. North Carolina CE Compliance Date: A transition of CE due dates to the licensee's birth month and year is in progress. The first biennial compliance period is prorated for agents licensed before 1/1/2008. The conversion formula is found at the Department's website (see Existing Licensee CE chart). Agents born in an even year have prorated CE hours for 2008. On 8/27/2008, NC announced an extension to licensees with CE due in January November 2008. Expiration dates for those with CE due in any month of 2008 will display a placeholder date of 12/31/2008 on the NC licensee website lookup. Agents whose 2008 CE due date has already passed should complete CE immediately. Prometric will send CE reminders in Sept 2008.
